Election of directors

Directors of Marcham Community Group are also Trustees under charity law. The Board consists of at least three and not more than twelve directors/trustees (one of whom is a Parish Council nominee), of which nine are open for election.

Under our Articles, one third of the elected trustees, in order of length of service in office, stand down and will be eligible to stand again for election as directors at this AGM. Dan Barnes is standing down by rotation and is eligible for re-election. Two other trustees, Simon Talbot and Mike Hoath, were copted during the year and therefore also stand down. Mike is standing for election, but Simon has decided not to, due to other commitments. There are, therefore, three trustee seats open for election, with two candidates (Dan Barnes and Mike Hoath) currently standing, so there is a potential vacancy.

There is an opportunity for any member interested in becoming a trustee to stand for election. We would be happy to explain what is involved. A nomination form for directors is below. Please return completed nominations to the address on the form by midday on Wednesday 4th November.
